Information Asset Management

- Document and manage information assets and information flows on a single platform, with optional process mapping views.
 - Map information assets to information flows, processes, DPIA's, breaches, risks, actions, SAR's and FOI's.
 - Export content into Excel or PDF.

GDPR Obligation Management

- Raise, track and manage Subject Access Requests and FOI Requests, including any resulting actions.
- Grant system access to Data Subjects, enabling them to securely access their case file and data via the platform (negating the need for email).
- Perform annual GDPR role declarations, to ensure your staff understand and attest to their specific GDPR role (Controller, DPO, Processor).

Monitoring and Reporting

- Drill down into content that requires further attention and filter data according to various criteria.
